- ➔ Any physician or LIP responsible for the care of the patient
- ➔ May not be written as PRN or as a standing order or in a protocol
- ➔ **MD must order** for each episode of restraint or seclusion use—verbal/telephone orders no longer necessary!

Violent Restraints:

Ordering Requirements

Original and Renewal Orders For **Violent Restraints** may not exceed 24 hours with the following intermittent order time limitations:

Time Limit **MAY NOT** exceed:

- ➔ Four (4) hours for ages 18 and older
- ➔ Two (2) hours for ages 9-17
- ➔ One (1) hour for ages 8 and under

Violent Restraints

Face –to -Face Assessment Required in **ONE HOUR**

Documentation must demonstrate evaluation of the patient's:

- ➔ Immediate situation
- ➔ Reaction to the intervention
- ➔ Medical/behavioral condition
- ➔ Need to continue/terminate restraint or seclusion

Monitoring Requirements

After 24 hours, BEFORE writing a new order for the use of restraints or seclusion, you must see and assess the patient

Restraints/seclusion should be D/C'd at the earliest possible time, regardless of the time identified in the order

➔ One of your colleagues (**or you**) will be getting a call at 2300 hours on 2/6/10 to renew the restraint order, if still needed

- ➔ Once you renew the initial order during rounds, the order alert will populate Provider Inbox daily around 5:15am beginning the next morning. This is your reminder to Renew or DC the restraint order, and complete the Menon note.
